## Terms of Use and Privacy Policy

IMPORTANT—READ CAREFULLY: By becoming a member of the People of America Foundation's Americans All program at no charge and upgrading that membership to join the Social Legacy Network, YOU HEREBY AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND PRIVACY POLICY. IF YOU DO NOT AGREE, DO NOT COMPLETE YOUR REGISTRATION.

The People of America Foundation (Foundation) is the parent organization of Americans All, a unique, community-outreach program that specifically benefits students participating in non-academic school activities, and supports the businesses and professional service providers in their local communities. It supports legacy preservation. Its fully developed storytelling tool is an ideal vehicle to help our nation focus on its commonalities, rather than its differences. By sharing stories, we can all recognize the contributions of every individual, while reinforcing the values of diversity and respect, and promoting tolerance, acceptance, empathy, and understanding. and excellence in K–12 social studies instruction.

The Americans All Benefit Corporation is the Foundation's marketing and operations arm. The Foundation enables individuals, schools, and nonprofit organizations (sponsors) to capture and record the personal histories and life experiences of those important to them (honorees) at no cost. Businesses pay a nominal fee (currently \$98/year in two installments) to our marketing partner, the Americans All Benefit Corporation, to share their stories, expand their outreach and provide discounts on goods and services to our members. After a one-year free trial, our members can join the Benefit Corporation's program to continue receiving discounts on goods and services for a small monthly fee of \$4/month so that they and their families can continue to receive benefits. We will not invoice members for the Social Legacy Network without their permission.

Legacy stories reflect members' views and are not vetted for accuracy. However, all text is filtered through a third-party, secure Profanity App to ensure that they do not contain inappropriate language. If requested, our editorial staff can override the App if they feel the identified word or phrase is acceptable by today's standards.

We comply with the "Children's Online Privacy Protection Act" of 1998 and therefore disallow children under 13 from putting personal information on our site. The program focuses on high school juniors and seniors. Juniors maintain their free membership until their class graduates and seniors maintain their free membership for one full year after they enroll, even if they have graduated prior to their one-year expiration date.

All content and images published on our site are considered to be in the public domain unless it is clearly noted that they are protected by copyright laws. We cannot provide permission for commercial use. However, content can be reproduced from our site for educational or personal use as long as a citation is provided.

#### 1. General Terms and Conditions

In addition to being published on the Americans All Heritage Honor Roll, members can get more exposure for a story by entering the 6-digit ID number of a Legacy Partner(s) to host their story on their landing page. There is no cost for a nonprofit or a school to become a Legacy Partner.

You can always add Legacy Partners to host your story by going to your "Welcome Back" page and clicking on "Share my legacy story with a Legacy Partner" under the "Actions" tab. To facilitate sharing your story with others, each story is assigned a six-digit identification number preceded by "/node/" (e.g., /node/123456). After you have published your story, that identification information appears on your "Welcome Back" page under "Subject of Story." You can now easily vour story with others by using your customized **URL** share (e.g., www.americansall.org/node/123456).

Because they control their landing page(s), an organization can remove or reinstate a legacy story from its landing page at its discretion. You will receive an email from us if that happens. Please contact them directly to see if your story was removed in error, and if it was, ask them to reinstate it, which they can easily do. However, if a member has the same story removed from more than three Legacy Partner landing pages without providing Americans All with a valid explanation, Americans All has the right to remove that story from the Heritage Honor Roll.
